

### Rules

1. Campsites must be kept neat and clean. It is the responsibility of the camper to remove all personal belongings and refuse when they leave the campground.
2. Monthly and seasonal campers are required to trim the area under their camper and an area three feet out from their camper, the utility service pole, power cords, hoses, cables and other materials stored near the camper.
3. Open fires must be contained in the fire rings. Campers are required to keep fire rings clean of refuse/litter. Please remember it is illegal to burn refuse/litter. Please purchase your firewood locally to help prevent the spread of disease and invasive species.
4. Dogs and cats must be leashed when outdoors and remain indoors when the pet owner is not present. Excessive barking is prohibited. Owners are required to clean up after their pets.
5. Loud, unnecessary, or unusual noise is prohibited. Quiet time is between 10:00 p.m. and 8:00 a.m.
6. Payment is expected before you set-up your camper. You may leave your payment with the Police Dept., at City Hall, or in the drop boxes located in the park or at City Hall. Wi-fi passwords will be given once payment is received.
7. We are a family friendly campground. Please drive slowly and watch for children.
8. Golf Carts and ATVs may be driven on the roads only. All children on carts and ATVs must be accompanied by an adult. You must be 16 to drive a cart or ATV, no exceptions. You must have a city permit even in city parks.

### Policies

9. The Campground is officially open from the beginning of May until September 30, but it will be open day to day after Sept 30. Opening date will depend on the weather. Utilities will be turned on as soon as weather permits and shut off when the weather makes it necessary.
10. All seasonal spots must have the deposit to reserve the following summer and all past due amounts paid by January 1 to reserve for the following summer. If the deposit and past due amounts are not received by January 1, the spot will be offered to the first person on the waiting list. No exceptions. All deposits must be made in U.S. Currency.
11. By June 1, all seasonal spots must be paid in full. No exceptions. All deposits must be paid in U.S. Currency.
12. Campsite rates are reviewed every year after the season is finished. Rates are subject to change and the deposit does not secure the rate for the following season. Rates will be set by council action in January for the upcoming season.
13. There is a 12 pm checkout time for campers that are not seasonal. Arrangements can be made if one needs a few more hours. If arrangements are not made, campers will be charged an additional day for checkouts after 12pm. The weekly rate is for seven (7) days; there will be no exceptions.
14. Do not use Wi-Fi extenders- it can interfere with the signal and cause interruptions in service. If you are having signal issues, please let our office know so we can have Wiktel troubleshoot.
15. Cancellations made more than 7 days before the scheduled arrival date will be refunded reservation fee and the deposit (if applicable) minus a \$20.00 cancellation fee. No refunds will be given for cancellations made 7 days or less before the scheduled arrival date and forfeit any deposit.
16. Locking Fee: If the party wishes to lock in a particular campsite using our online reservation software there is a \$5 lock fee.

Campers who do not follow these rules and policies may be evicted by the City Police or the Kittson County Sheriff's Office.
